RESPONSIBLE PET OWNER AGREEMENT

Radius Housing understands and recognises keeping pets offers significant benefits to their owners and therefore would encourage this.

By signing this Responsible Pet Owner Agreement you are confirming that you will keep to the below conditions in which Radius will permit a pet to be kept at your home:

CARE OF YOUR PET

1. You will ensure your pets welfare.
2. Your home must be suitable for the type of pet you want, considering the size of your home, the size of your pet and outside space available.
3. You must get your dog micro chipped.

CLEAN UP FOULING

4. All fouling will be cleared up immediately and disposed of safely and hygienically.
5. Pet owners with private gardens will regularly clean their garden and keep it clear of fouling so that it does not cause nuisance for neighbours.
6. Pet owners with a communal garden must not allow their pet to foul in any communal areas as it can cause a nuisance for neighbours.

KEEP YOUR PET UNDER CONTROL

7. All dogs will be kept on a lead in all public places in our schemes, including communal gardens, footpaths and car parks.
8. Pets will be kept under control and be supervised by a responsible person over the age of 16.
9. Pets will not be allowed to damage any Radius property. You will be responsible for paying for any repairs.

BREACH OF TENANCY AND YOUR PET

10. Pets must not cause a nuisance to neighbours. This includes excessive barking, other noise and/or damage to other peoples home.
11. You will not run a pet-sitting or kennelling service at your home without Folds written permission.
12. You will not breed dogs at your home.
13. Your pet must not injure a person in a private or public place.
14. You must take your pet with you if you terminate your tenancy.

I agree to the terms of this agreement. I understand that if I breach this agreement and/or my tenancy conditions, permission to keep a pet may be withdrawn in addition to any other action Radius may take.
